On motion by John Giordullo, seconded by Trenika Mitchell and passed unanimously, the Minutes of the Sterile Compounding Task Force meeting of December 3, 2015, were approved.

After discussion, Robin Walters moved to present the proposed changes to 201 KAR 2:076 to the Board of Pharmacy at the next Board meeting. Laura Stiles seconded, and the motion passed unanimously.

The Task Force continued discussion regarding supervision of compounding. At this time, no changes to the statutory definition of supervision will be brought to the Board of Pharmacy. There needs to be a pharmacist's presence supervising sterile compounding to make sure the compounding is being performed properly.

There was continued discussion regarding the Sullivan College of Pharmacy intern's suggestion of a universal auxiliary label with information regarding a 12 hour beyond use date (BUD) being developed that pharmacists would have the option of using should the BUD need to change due to facility issues or the preparation being compounded in a segregated compounding area. This auxiliary label would draw attention to the new, non-standard BUD. It would be voluntary for facilities to use the label but would be available. Barbara Jolly moved for the student chapters at Sullivan College of Pharmacy and the University of Kentucky College of Pharmacy to develop a prototype and this prototype be brought to the Board of Pharmacy for consideration. Trenika Mitchell seconded, and the motion passed unanimously.

On motion by Amanda Harding, seconded by Michelle Deluca Fraley and passed unanimously, the Sterile Compounding Task Force meeting was adjourned at 1 p.m.

There is no need for any more meetings of the Sterile Compounding Task Force.
