MINUTES
KENTUCKY BOARD OF PHARMACY
23 Millcreek Park
Frankfort, Kentucky
October 8, 2003

CALL TO ORDER: A regular meeting of the Kentucky Board of Pharmacy was held at the Board office, 23 Millcreek Park, in Frankfort, Kentucky. President Jones called the meeting to order at 9:00 a.m.

Members present: Georgina Kindall Jones, Tim Armstrong, Joe Carr, Becky Cooper, Mark Edwards, and Patricia Thornbury. Staff present: Michael A. Moné, Executive Director; Jeffrey L. Osman, Pharmacy Inspections and Investigations Coordinator; Katie Busroe, Maxine Snively, and Philip C. Losch, Pharmacy and Drug Inspectors; Cheryl Lalonde-Mooney, Assistant Attorney General and Board Counsel; and Shannon Settles, Executive Secretary. Guests: Danna Droz; Brian Fingerson, Pharmacist Recovery Network; Ralph Bouvette, APSC; Nancy Horn, APSC; J.D. Hammond, APSC; Greg Naseman, CVS; Paula York, Drug Control; and Brenda Burnett and Tracy Greenwell, University of Kentucky College of Pharmacy intern students. Juanita Toole, Court Reporter, recorded the meeting.

APPEARANCES: **Cardinal Health/Gary Cacciatore.** The Board reviewed correspondence regarding hospitals being allowed to transmit medication orders to an off-site Pharmacy Service Center where pharmacist can review, enter, and approve the orders during times the pharmacy is closed. After a brief discussion, Mr. Carr moved to approve the request as long as the individual pharmacist is licensed in Kentucky and posts their license in their working facility. Mr. Edwards seconded and the motion passed unanimously.

American Cancer Society/Cindy Adams. The Board reviewed correspondence regarding amending KAR 201:240 to allow those entities to accept unused, unopened drugs from health facilities where the drugs have been under the supervision of a health care provider. After a brief discussion, Mr. Carr moved to review the information at the Board retreat. Mr. Edwards seconded and the motion passed unanimously.

Colin Bayliss. The Board reviewed correspondence regarding Mr. Bayliss obtaining licensure in Kentucky. After a brief discussion, Ms. Thornbury moved to allow Mr. Bayliss licensure with conditions in Kentucky provided he completes the Kentucky Board of Pharmacy practical examination, NAPLEX, and the MPJE. Mr. Carr seconded and the motion passed. Mr. Armstrong opposed.

MINUTES: On motion by Mr. Carr, seconded by Ms. Thornbury and passed unanimously, the Minutes of September 23, 2003 were adopted.

BOARD REPORTS: **President.** President Jones welcomed Greg Naseman to the Board.

Executive Director. Mr. Moné was informed that there are approximately 12 University of Cincinnati students who intend to take our Board examination in June. However, their graduation

isn't until after the deadline for all materials to be submitted. Mr. Moné requested the Board to allow University of Cincinnati June 2004 Board examinees only an extension of time to file their certificate of graduation portion of their application only. All other forms must be filed by the deadline of May 21, 2004. Mr. Edwards moved to approve the request. Mr. Carr seconded and the motion passed unanimously.

Mr. Moné informed the Board that Tim Armstrong, Patricia Thornbury, and himself will be meeting with the P&T committee regarding tablet splitting on October 9th.

CORRESPONDENCE: American Red Cross/Guy Stinson. The Board reviewed correspondence requesting clarification of state regulations regarding distribution of not-for-human-consumption samples. After a brief discussion, Ms. Thornbury moved to authorize Mr. Moné to draft a letter clarifying the regulation. Mr. Armstrong seconded and the motion passed unanimously.

PharmaStat/Bernie Gregorowicz. The Board reviewed correspondence requesting clarification of labeling of split tablet medications and the signing of oral schedule III, IV, and V controlled substance prescriptions by pharmacists. After a brief discussion, Mr. Edwards moved to allow the current procedures of labeling for split tablets by the pharmacy. On the second part of the question, Mr. Edwards expressed that oral prescriptions listed in schedule III, IV and V shall be immediately reduced to writing, dated, and signed by each responsible pharmacist. Mr. Carr seconded and the motion passed unanimously.

Luther Luckett Correctional/Doug Crall. The Board reviewed correspondence regarding Luther Luckett's protocol for dealing with emergency situations requiring the procurement of medications ordered by a licensed prescriber. After a brief discussion, Ms. Thornbury moved to place this on the agenda for the November retreat to be discussed. Ms. Cooper seconded and the motion passed unanimously.

The Board reviewed correspondence requesting permission to store all prescription registers and original hardcopy prescriptions greater than one year off site in a secure storage building. Owensboro Medical Practice. The Board reviewed correspondence regarding pharmacists

switching the prescriber of a prescription from an ARNP to the physician. Ms. Thornbury moved to authorize Mr. Moné to draft a letter. Mr. Carr seconded and the motion passed unanimously.

Medix.resources inc/Irene Tam. The Board reviewed a questionnaire.
