CALL TO ORDER: A Special Called Board Meeting was held at the Kentucky Board of Pharmacy at the Board office at 125 Holmes Street, State Office Building Annex, Suite 300, Frankfort, Kentucky. President Greenwell called the meeting to order at 9:04 a.m.

201 KAR 2:380 Amendment: This Special Called Meeting was called to review amendments to 201 KAR 2:380, originally filed October 12, 2017. Senator Julie Raque Adams, Health and Welfare Chair, suggested a Working Group be formed to discuss 201 KAR 2:380 to come to a consensus. The Working Group met about November 27, 2017, and included representatives from the Board of Pharmacy, KPhA, KMA, and KAFP.

After much discussion, Dr. Martin moved to accept the amendments to 201 KAR 2:380. Mr. Poole seconded, and the motion passed unanimously.

President Greenwell directed Ms. Lalonde to file 201 KAR 2:380 as amended with the Health and Welfare Committee so that it will be on the December 13, 2017 Agenda.
