Mr. Chris Killmeier called the meeting to order at 10:12 a.m. Committee members present were: Dr. Sarah Lawrence, Dr. Lisa Hart, Dr. Matt Martin and Dr. Joseph Bickett. Guests present were: Larry Hadley, Executive Director of the Board of Pharmacy, Katie Busroe, Pharmacy Inspections and Investigations Coordinator, Cheryl Lalonde, Board Attorney, Paula York, OIG, Dr. Anne Policastri, KSHP, Adam Chesler, Cardinal Health, Claire Stall, APSC, Jenny Ryan, Genoa, Lavanya Peter, Caitlyn French, Hillary Lamb and Jenna Ryan.

Dr. Lawrence made a motion to approve the November 15, 2017, Minutes with the following amendment; change from November 15, 2018 to November 15, 2017. The motion was seconded by Dr. Bickett and the motion passed unanimously.

Continuing Education 201 KAR 2:015: The council reviewed additional changes to regulation, 201 KAR 2:015. The council instructed Ms. Lalonde to amend the proposed regulation to include the following;

1. provider may apply up to 60 days prior to presentation and up to 30 days after presentation;
2. pharmacist may apply 30 days after program for approval, and;
3. the addition of a 60 day pre-approval.

The updated regulation and forms will be presented to the council at its next meeting.

The Council resumed its discussion of Telepharmacy regulation in other states. Adam Chelser, Cardinal Health, offered a state by state comparison chart with definitions and model regulation language. Dr. Lawrence offered to bring back sample regulation and definitions at the next meeting. The Council will continue the discussion at the next scheduled meeting.

The next meeting date is April 18, 2018 at 10:00 am at the Board office.

Dr. Lawrence made a motion to adjourn. Dr. Martin seconded and the motion passed unanimously. The meeting was adjourned at 12:10 p.m.
