CALL TO ORDER: Chairwoman Lamkin called the meeting to order at 9:04 am.

**MINUTES:** Peter Cohron made a motion to approve the minutes from the Aug 17, 2022, meeting. Lisa Bradley seconded, and the motion passed unanimously.

**KYPRN REPORT** Emily Caporal gave the KYPRN report. 27 total clients with 22 of those clients known to the BOP. Items on the report were discussed among the members. **Action:** Peter Cohron made a motion to suspend testing for 90 days for TG due to severe illness. She will have to start her 6 months of sobriety over upon resuming testing. Lisa Bradley seconded the motion and it passed unanimously.

### **GENERAL COUNSEL UPDATE**

**KYPRN Contract Update** General Counsel Eden Davis, presented the KYPRN updated contract that includes medications used in the treatment of alcoholism in addition to those used for opioid use disorder. There was discussion about adding language that an individual may request "guidance" about OTC medications verses asking permission to take OTC medications. The committee will review evidence-based research on these types of medications and the point was made that it is important to cite the sources of this guidance. The members also agreed that an individual should report OTC medication use upon taking the medication and in writing. **Action** Lisa Bradley made a motion to add these updates to the contract language. Jessica Johnson seconded, and the motion passed unanimously.

**ADJOURNMENT** Lisa Bradley made a motion to adjourn the meeting and Hannah Johnson seconded. The motion passed unanimously. The meeting adjourned at 9:38 am.
