**MINUTES**

Members present via teleconference: Chairman Michael Burleson, Cathy Hanna, Chris Palutis, Kimberly Croley, Ralph Bouvette, Jennifer Grove, and Chris Killmeier. Board members/staff: John Fuller, Board President; Christopher Harlow, Executive Director; Eden Davis, General Counsel, Paul Daniels and Amanda Harding, Pharmacy and Drug Inspectors, and Nikki Holiday, Executive Assistant.

Chairman Michael Burleson called the meeting to order at 9:00 a.m.

**Minutes:** Chris Palutis moved to approve the minutes from the July 7, 2023 meeting. Jennifer Grove seconded, and the motion passed unanimously.

**Final Product Verification – Proposed Amendment to 201 KAR 2:210:** The Committee reviewed and discussed the proposed amendments to 201 KAR 2:210 and made the following actions:

**Action:** Cathy Hanna motioned to add the word “affixed” prior to the word “label” in (3) and (4) in the definitions section. Chris Palutis seconded, and the motion passed with Chris Killmeier opposing.

**Action:** Kim Crowley motioned to accept all the changes made in Section 1. Cathy Hanna seconded, and the motion passed unanimously.

**Action:** Cathy Hanna motioned to send this regulation back to the Board for guidance on the language in Section 4 about “quality assurance” and “automation.” Jennifer Grove seconded, and the motion passed unanimously.

**Action:** Kim Crowley motioned to send the regulation back to the Board with the Committee’s changes and to seek guidance on the above-mentioned action. Cathy Hanna seconded, and the motion passed unanimously.
