MINUTES

Chairperson Trish Freeman called the meeting to order at 1:10 p.m. Members present: Larry Hadley, Ralph Bouvette, Katie Busroe, Craig Martin and Chris Killmeier. Staff: Darla Sayre, Executive Staff Advisor; Anthony Gray, Board Counsel and Amanda Harding, Pharmacy and Drug Inspector. Absent: Chris Palutis. Guests: Brittany Tyler, Pharmacist Intern.

Craig Martin moved to accept the minutes of the February 20, 2019 meeting. Larry Hadley seconded, and the motion passed unanimously.

201 KAR 2:175 and 201 KAR 2:330 – After discussion, the committee directed Anthony Gray to insert language from HB 64 to each regulation to be presented at the next meeting.

902 KAR 20:036 – Larry Hadley requested direction on the proposed Personal Care regulation. This regulation does not comply with 201 KAR 2:370. The committee directed Larry Hadley to respond during the comment period of this regulation.

201 KAR 2:170 – After discussion, Chris Killmeier moved to recommend to the Board to ‘Keep As Is’. Craig Martin seconded, and the motion passed unanimously.

Unused Permits Regulation – Anthony Gray presented to the committee proposed wording for unused permits. After discussion, the committee directed Anthony Gray to proceed with the proposed wording inserting the language into 201 KAR 2:106.

201 KAR 2:106, 201 KAR 2:105 and 201 KAR 2:320– After discussion, these regulations were tabled until the next meeting for sample wording from the NABP Model Act and other state boards of pharmacy.

Repository Regulation – This item was tabled until the next meeting for additional information.

201 KAR 2:280 - Chairperson Freeman will present revisions to this regulation at the next meeting.

On motion by Chris Killmeier, seconded by Larry Hadley and passed unanimously, Chairperson Freeman adjourned the meeting at 2:50 p.m. The next meeting will be held on July 18, 2019 at 9:00 a.m.
