**October 15, 2018**

**MINUTES**

Chairperson Trish Freeman called the meeting to order at 9:03 a.m. Members present: Ralph Bouvette, Larry Hadley, Chris Killmeier, Katie Busroe, Craig Martin, Trish Freeman and Chris Palutis. Staff: Darla Sayre, Executive Staff Advisor. Guest: Helen Thompson, UK College of Pharmacy Intern.

Mr. Hadley presented a proposal received from Baxter Healthcare regarding a new regulation for a special pharmacy permit for dialysate. After much discussion, Dr. Freeman suggested that this discussion be tabled allowing each committee member study this proposal.

Ms. Lalonde joined the meeting at 9:25 a.m.

Mr. Killmeier moved to accept the minutes of the September 4, 2018 meeting. Dr. Martin seconded, and the motion passed unanimously.

**201 KAR 2:010** – Dr. Bouvette moved to make the following changes;

Line 14, page 1 – Change American to Accreditation,  
Line 15, page 1 – Delete,  
Line 16, page 1 – Change Guidelines to Key Elements,  
Line 27, page 2 – Delete,  
Line 30, page 2 – Delete,  
Line 31, page 2 – Delete,  
Line 32, page 2 – Change Guidelines to Key Elements, and  
to allow Board staff to verify all references and addresses listed to insure accuracy and make changes as warranted. Dr. Martin seconded, and the motion passed unanimously.

**201 KAR 2:090** – Dr. Bouvette moved to make the following changes;

Delete Sections 1, 2, 4 and 5.  
Change Section 3 to Section 1 to read as follows;

- (a) The pharmacy shall have appropriate reference material and equipment as dictated by experience to meet the needs of the particular pharmacy and necessary to practice pharmacy in a safe manner.
- (b) Electronic references shall be acceptable.

Dr. Martin seconded, and the motion passed unanimously.

**201 KAR 2:095** – Mr. Killmeier moved to make the following changes;

Change title to read – 201 KAR 2:095 Pharmacist Interns.

Change Section 1 to read – A pharmacist intern may practice pharmacy under the supervision and direction of a licensed pharmacist.

Delete Section 2.

Change Section 3 to Section 2.

Dr. Martin seconded, and the motion passed unanimously.

**201 KAR 2:100** – Dr. Martin moved to make the following changes;

Change Section 1 to read as follows;

Section 1 (a) A pharmacy shall provide adequate security and control of its controlled substances and prescription legend drugs.

(b) In the absence of a pharmacist, the pharmacy must be closed.

Direct Ms. Busroe and Ms. Lalonde to edit wording for lines 10-15, page 1.

Delete 'Owners of prescription....enclosing the prescription department. Lines 15-19, page 1.

Delete 'Emergency drugs....absence of a pharmacist. Lines 7-10, page 2.

Delete Section 5 and direct Ms. Lalonde to compile all references to unprofessional conduct into a new regulation.

Mr. Killmeier seconded, and the motion passed unanimously.

Dr. Freeman proposed the next meeting to be held November 6, 2018 at 1:00 p.m to 4:00 p.m.

Dr. Freeman suggested skipping 201 KAR 2:105 and 201 KAR 2:106 due to the length involved with these regulations. The committee will begin the November 6<sup>th</sup> meeting with 201 KAR 2:115.

On motion by Dr. Martin, seconded by Mr. Killmeier and passed unanimously, Chairperson Freeman adjourned the meeting at 11:08 a.m.
