# REGULATION COMMITTEE via teleconference October 20, 2021 10:08 a.m.

### **MINUTES**

Chairperson Ralph Bouvette called the meeting to order at 10:08a.m. Members present via teleconference: Ralph Bouvette, Cathy Hanna, Joel Thornbury, Chris Palutis and Elisah Bischoff. Absent: Michael Burleson, Jennifer Grove, Chris Killmeier and Kimberly Croley. Staff: Eden Davis, General Counsel and Darla Sayre, Executive Staff Advisor.

Joel Thornbury moved to accept the minutes of the August 25, 2021 meeting with one correction. Elisha Bischoff seconded, and the motion passed unanimously.

**Repository Regulation** Eden Davis provided a draft of the regulation with the revisions from the previous meeting. There was discussion regarding the word 'dispenser' throughout the regulation as it was unnecessary and on separation of donated stock from regular stock. The committee was in favor of electronic separation in conjunction with physical separation but did not want electronic separation to be mandatory.

**Action:** Joel Thornbury approved the revised draft for presentation to the Board at the next meeting. Cathy Hanna seconded, and the motion passed unanimously.

**Out of State pharmacy permits.** The committee continued to review the Out of State Pharmacy Permit regulation draft. After discussion, the following revisions were made:

- Section 1 resident pharmacy inspection within the previous twenty-four (24) month period;
- Strike Section 2 (3) and change another pharmacist to staff pharmacist in Section 2 (4);
- Strike Section 4;
- Section 5 (1)(a) change or to and;
- Section 5 (2)(b)(c) add currently required information for owner/officers to this section;
- Section 5 (2)(c) add other non-corporate business entities;
- Section 5 (3)(e) add 'FDA approved manufacturer guidelines for storage'

The committee will continue to review this draft at the next meeting.
