ORDER TERMINATING AGREED ORDER

At its May 16, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel B, considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Agreed Order filed of record June 4, 2019.

In addition to the licensee's request, the Panel has considered a Memorandum by the Board's General Counsel, dated March 15, 2024; the Agreed Order filed of record June 4, 2019; Center for Personalized Education for Professionals ("CPEP") Medical Record Keeping and Personalized Implementation Program (PIP) Final Report, dated February 4, 2020; CPEP PIP Addendum Correspondence and Reviews, dated August 4, 2020; CPEP PROBE Program Evaluation and Assessment Report, with licensee's essay attached, dated August 15, 2019; CPEP PROBE Program Evaluation and Assessment Report, with licensee's essay attached, dated March 26, 2020; Board consultant reports, with Expert Review Worksheets, dated December 29, 2021 and August 11, 2023; the Board consultant's final report, dated October 13, 2023; and Compliance Inspection Reports prepared by Kevin Payne, Medical Investigator, dated August 5, 2020; July 29, 2021; March 11, 2022; November 17, 2023 and February 8, 2024.

Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Agreed Order in this Case


No. 1913 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
