**ORDER TERMINATING ORDER OF PROBATION**

At its April 25, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Hearing Panel A considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Order of Probation filed of record August 25, 2021.

In addition to the licensee's request, the Panel has considered a memorandum by the Board's General Counsel, dated February 27, 2024; the Order of Probation filed of record August 25, 2021; Jefferson Circuit Court, Case No. 21-CI-005391, Opinion and Order, dated January 11, 2024; Center for Personalized Education for Professionals ProBE Program Evaluation and Assessment Report, dated November 24, 2021; the licensee's essay; and Compliance Inspection Reports prepared by Kevin Payne, Medical Investigator, dated November 29, 2021 and February 8, 2024.

Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Order of Probation in this Case No. 1980 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
