**ORDER TERMINATING
SIXTH AMENDED AGREED ORDER**

At its November 21, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel B, considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Sixth Amended Agreed Order filed of record March 24, 2023.

In addition to the licensee's request, the Panel has considered a Memorandum by the Board's General Counsel, dated August 6, 2024; the Sixth Amended Agreed Order filed of record March 24, 2023; Texas Medical Board, *Order Granting Termination*, dated June 21, 2024; correspondence from Tina F. Simpson, M.D., Medical Director, Kentucky Physicians Health Foundation, supporting the licensee's request, dated July 30, 2024; and Compliance Inspection Reports prepared by Billy Madden, Medical Investigator, dated February 22, 2018; January 10 and July 11, 2019; June 10, 2020; January 15, 2021; January 2 and June 24, 2022; January 12 and June 28, 2023; and January 12 and July 12, 2024.

Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Sixth Amended Agreed Order in this Case No. 1779 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
