**ORDER TERMINATING
FIFTH AMENDED AGREED ORDER**

At its May 16, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel B, considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Fifth Amended Agreed Order filed of record July 31, 2023.

In addition to the licensee's request, the Panel has considered a Memorandum by the Board's General Counsel, dated March 14, 2024; the Fifth Amended Agreed Order filed of record July 31, 2023; correspondence from Tammy Bernard, Aesthetic Health and Wellness, dated January 9, 2024; South Carolina Board of Medical Examiners Order, dated February 21, 2024; correspondence from Tina F. Simpson, M.D., Medical Director, Kentucky Physicians Health Foundation, supporting the licensee's request, dated March 11, 2024; and Compliance Inspection Reports prepared by Billy W. Madden, Medical Investigator, dated July 15, 2020; January 15 and December 6, 2021; June 23, 2022; January 18 and June 28, 2023; and January 12, 2024. The Panel also required that the licensee acknowledge having read the "Board Opinion Re: Practice Drift".

Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Fifth Amended Agreed

Order in this Case No. 1914 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
