ORDER TERMINATING
AGREED ORDER

At its February 15, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel A, considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Agreed Order filed of record October 25, 2022.

In addition to the licensee's request, the Panel has considered a memorandum prepared by the Board's Assistant General Counsel dated January 23, 2024; several letters of support; the Agreed Order filed of record October 25, 2022; Center for Personalized Education for Professionals ProBE Program Evaluation and Assessment Report, dated November 3, 2022; the licensee's essay; Acumen Assessments Professional Fitness for Duty Evaluation, dated January 16, 2023; correspondence from Jeff Rose, MBA, LCSW, dated October 3, 2023; Vanderbilt University Medical Center confirmation of the licensee's completion of the course *Maintaining Professional Boundaries*, January 25 – 27, 2023; and Compliance Inspection Reports prepared by Stephen W. Manley, Medical Investigator, dated February 23 and December 11, 2023.

Having considered all of these materials and being sufficiently convinced that the licensee will continue to abide by the terms and conditions previously fixed, without a formal Agreed Order, the Panel hereby ORDERS that the terms and conditions imposed upon the licensee's Kentucky medical license are hereby TERMINATED.
