**ORDER TERMINATING AGREED ORDER**

At its July 20, 2023 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel B, considered information that the Washington Medical Commission (“Washington Board”) issued a Stipulation to Informal Disposition regarding the medical license held by the licensee. The licensee failed to disclose the Washington action within ten (10) days. The Panel and the licensee resolved the matter by entering into an Agreed Order filed of record August 7, 2023, pursuant to which the licensee was fined \$1,000.00 and required to submit documentation of the completion of the comprehensive continuing medical education (“CME”) course required in the Washington’s Stipulation of Information Disposition and provide the Board with a copy of the paper that the licensee is required to submit related to the CME. The Agreed Order provided that the Board shall terminate the Agreed Order upon full payment of the fine and receipt of the CME documentation of completion and paper related to the CME.

The Board has received and processed the payment of the fine in the amount of \$1,000.00 and has received the CME documentation and the required paper.


Having considered all of this information and being sufficiently advised, the Board, acting by and through the Chair of its Inquiry Panel B, hereby **ORDERS** that the Agreed Order in this Case No. 2114 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
