**ORDER TERMINATING AGREED ORDER**

At its August 17, 2023 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel A, considered information that the Medical Board of Mississippi issued a Corrected Determination and Order regarding the medical license held by the licensee. The licensee failed to disclose the Mississippi action against her license within ten (10) days as required by 201 KAR 9:081(9)(2)(a)(2). The Panel and the licensee resolved the matter by entering into an Agreed Order filed of record September 7, 2023, pursuant to which the licensee was fined \$1,000.00 and required to provide an affidavit attesting to the fact that the licensee read 201 KAR 9:016, 201 KAR 9:260 and the Board Opinion Regarding the Use of Telemedicine Technologies in the Practice of Medicine (September 15, 2022). The Agreed Order provided that the Board shall terminate the Agreed Order upon full payment of the fine and receipt of the affidavit.

The Board has received and processed the payment of the fine in the amount of \$1,000.00 and has received the affidavit.


Having considered all of this information and being sufficiently advised, the Board, acting by and through the Chair of its Inquiry Panel A, hereby **ORDERS** that the Agreed Order in this Case No. 2118 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
