**ORDER TERMINATING AGREED ORDER**

At its November 21, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel B, considered a request by the licensee to terminate the terms and conditions imposed upon her Kentucky medical license by Agreed Order filed of record June 3, 2024.

In addition to the licensee's request, the Panel has considered a Memorandum by the Board's General Counsel, dated October 9, 2024; the Agreed Order filed of record June 3, 2024; Center for Personalized Education for Professionals ("CPEP") ProBE Program Evaluation and Assessment Report, dated August 24, 2024; ProBE Final Essay; Certificate of Completion, ProBE, CPEP, August 8-10, 2024; and a Compliance Inspection Report prepared by John W. Lewis, Medical Investigator, dated October 8, 2024.

Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Agreed Order in this Case No. 2162 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
