Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Agreed Orders in Case Nos. 1954 and 1982 be and are hereby **TERMINATED**, effective immediately upon the filing of this Order.
