**ORDER TERMINATING
AMENDED AGREED ORDER**

At its August 17, 2023 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel A considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Amended Agreed Order filed of record August 22, 2019.

In addition to the licensee's request, the Panel has considered a memorandum by the Board's General Counsel, dated July 12, 2023; the Amended Agreed Order filed of record August 22, 2019; Center for Personalized Education for Professionals Summary Report, released June 15, 2020; Board consultant reports, dated May 5, 2021; January 17, 2022; January 16 and June 5, 2023; Licensee's responses to Board consultant reports, dated May 25, 2021 and February 11, 2022; Board consultant's final responses, dated July 19, 2021 and March 7, 2022; and Compliance Inspection Reports prepared by John W. Lewis, Medical Investigator, dated April 8, July 26 and December 16, 2021; March 28, 2022 and February 22 and June 7, 2023.

Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Amended Agreed Order in this Case No. 1843 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.


