ORDER TERMINATING
FOURTH AMENDED AGREED ORDER

At its April 25, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel A considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Fourth Amended Agreed Order filed of record October 27, 2021.

In addition to the licensee's request, the Panel has considered a memorandum by the Board's General Counsel, dated February 27, 2024; the Fourth Amended Agreed Order filed of record October 27, 2021; Board consultant reviews [with Expert Review Worksheets] dated, March 2022, May 2023, and February 2024; correspondence from Holly Scott, Compliance Officer, State Medical Board of Ohio, dated April 12, 2023; correspondence from Tina F. Simpson, M.D., Medical Director, Kentucky Physicians Health Foundation, supporting the licensee's request, dated February 26, 2024; and Compliance Inspection Reports prepared by Jon Marshall, Medical Investigator, dated February 7 and August 7, 2019; February 5 and August 5, 2020; February 2, 2021; February 3 and August 2, 2022; February 2 and August 2, 2023; and February 6, 2024.


Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Fourth Amended Agreed Order in this Case No. 1842 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
