At its October 17, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel A considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Agreed Order filed of record May 22, 2024.

In addition to the licensee's request, the Panel has considered a memorandum by the Board's General Counsel, dated September 23, 2024; the Agreed Order filed of record May 22, 2024; Certificate of Completion, *Medical Ethics and Professionalism - Extended* program, PBI Education, May 18-19, 2024; Certificate of Completion, *Maintenance and Accountability Seminar*, PBI Education, August 20, 2024; PBI Post-Course Participation Report, Accomplishments, Impressions, and Recommendations Letter, dated September 5, 2024; and a Compliance Inspection Report, prepared by Kevin Payne, Medical Investigator, dated September 12, 2024.

Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Agreed Order in this Case No. 2152 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
