ORDER TERMINATING AGREED ORDER

At its February 15, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel A, considered information that the Medical Licensing Board of Indiana issued a Final Order Accepting Proposed Settlement Agreement regarding the medical license held by the licensee. The licensee failed to disclose the Indiana action against his license within ten (10) days as required by 201 KAR 9:081(9)(2)(a)(2). The Panel and the licensee resolved the matter by entering into an Agreed Order filed of record March 7, 2024, pursuant to which the licensee was fined \$1,000.00 and required to submit documentation that he completed thirty (30) hours of remedial education on the appropriate prescribing of controlled substances and dangerous combinations, record keeping, and pain management and completion of CPEP program on pain management or the Vanderbilt Prescribing Controlled Drugs course. The Agreed Order provided that the Board shall terminate the Agreed Order upon full payment of the fine and receipt of the CME documentation of completion for the remedial education and courses required in Indiana's Final Order.

The Board has received and processed the payment of the fine in the amount of \$1,000.00 and has received the CME documentation.

Having considered all of this information and being sufficiently advised, the Board, acting by and through the Chair of its Inquiry Panel A, hereby **ORDERS** that the


Agreed Order in this Case No. 2143 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
