**ORDER TERMINATING**  
**ORDER OF INDEFINITE RESTRICTION**

At its August 17, 2023 meeting, the Kentucky Board of Medical Licensure, acting by and through its Hearing Panel A considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Order of Indefinite Restriction filed of record December 18, 2020.

In addition to the licensee's request, the Panel has considered a memorandum by the Board's General Counsel, dated June 23, 2023; the Order of Indefinite Restriction filed of record December 18, 2020; Vanderbilt University Medical Center, Center for Professional Health certification of the licensee's completion of *Proper Prescribing of Controlled Prescription Drugs: Critical Issues and Common Pitfalls* course on February 17-19, 2021; Center for Personalized Education for Professionals ("CPEP") PROBE Program, Evaluation and Assessment Report, dated June 3, 2021; the licensee's essay; CPEP PROBE Plus Program, Longitudinal Follow-up Program to the PROBE Seminar Program, Summary Evaluation, dated August 1, 2022; Case No. 2043 Agreed Order filed of record March 2, 2022; and Compliance Inspection Reports prepared by Kevin Payne, Medical Investigator, dated May 27 and December 12, 2022, and June 20, 2023.

Having considered all of this information and being sufficiently advised, the Panel hereby GRANTS the licensee's request and **ORDERS** that the Order of Indefinite


Restriction in this Case No. 1955 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
