ORDER TERMINATING AGREED ORDER

At its January 18, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel B, considered information that the State Medical Board of Ohio issued an Amended Order against the medical license held by the licensee. The Panel and the licensee resolved the matter by entering into an Agreed Order filed of record February 13, 2024, pursuant to which the licensee was required to provide documentation that he completed the course or courses on maintaining physician/patient boundaries and the course or courses on maintaining adequate and appropriate medical records required in Ohio's Amended Order within three (3) months of the completion thereof. The Agreed Order provided that the Board shall terminate the Agreed Order upon proof of completion of the courses.

The Board has received proof of the licensee's completion of the PBI Medical Record Keeping Course on January 6 & 7, 2024 and the PBI Professional Boundaries and Ethics Course on January 26 – 28, 2024.

Having considered all of this information and being sufficiently advised, the Board, acting by and through the Chair of its Inquiry Panel B, hereby **ORDERS** that the Agreed Order in this Case No. 2142 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
