ORDER TERMINATING
AGREED ORDER

At its February 15, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel A, considered a request by the licensee to terminate the terms and conditions imposed upon his Kentucky medical license by Agreed Order filed of record August 21, 2023.

In addition to the licensee's request, the Panel has considered a memorandum prepared by the Board's General Counsel dated January 17, 2024; correspondence from Scott A. Teitelbaum, M.D., Medical Director, Florida Recovery Center, dated October 17, 2023; the Agreed Order filed of record August 21, 2023; correspondence prepared by Tina F. Simpson, M.D., Medical Director, Kentucky Physicians Health Foundation, dated January 4, 2024, supporting the licensee's request; and a Compliance Inspection Report prepared by Stephen W. Manley, Medical Investigator, dated January 8, 2024.

Having considered all of these materials and being sufficiently convinced that the licensee will continue to abide by the terms and conditions previously fixed, without a formal Agreed Order, the Panel hereby ORDERS that the terms and conditions imposed upon the licensee's Kentucky medical license are hereby TERMINATED.
