**ORDER TERMINATING AGREED ORDER**

At its April 25, 2024 meeting, the Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel A, considered information that the College of Physicians and Surgeons of Ontario entered an *Undertaking, Acknowledgement and Consent* and the Missouri State Board of Registration for the Healing Arts entered a *Settlement Agreement and Consent Order on Discipline*. The licensee failed to disclose the College of Physicians and Surgeons of Ontario action within ten (10) days. The Panel and the licensee resolved the matter by entering into an Agreed Order filed of record May 22, 2024, pursuant to which the licensee was fined \$1,000.00 and provide an Affidavit that he has read the Board's "Opinion Regarding the Use of Telemedicine Technologies in the Practice of Medicine" and understands that he must comply with the acceptable and prevailing standards set forth therein as a condition of using telemedicine technologies in the practice of medicine with the Commonwealth of Kentucky. The Agreed Order provided that the Panel Chair may approve termination of the Agreed Order upon the licensee's request, full payment of the fine and receipt of the Affidavit.

The Board has received and processed the payment of the fine in the amount of \$1,000.00, received the Affidavit, and the licensee has requested termination.

Having considered all of this information and being sufficiently advised, Inquiry Panel A, acting by and through the Chair of its Inquiry Panel A, hereby **ORDERS** that

the Agreed Order in this Case No. 2158 be and is hereby **TERMINATED**, effective immediately upon the filing of this Order.
