#### **MINUTES**

Chris Harlow called the meeting to order at 1:00 p.m. on March 9, 2022. Members present: Ben Mudd; Julie Harting; Adrienne Matson; Craig Beavers; Meredith Figg and Katie Busroe. Staff present: Chris Harlow, Executive Director and Darla Sayre, Executive Staff Advisor.

Chris Harlow advised the Board at it's August 31, 2021 meeting charged the committee with the following:

- Evaluate the current definition and national trends for Continuous Professional Development (CPD)
- Develop a specific strategy to incorporate CPD into CE
- Make a recommendation to the Kentucky Board of Pharmacy (KBOP) on implementation of CPD for pharmacists and pharmacy technicians

**Election of Officers** Craig Beavers nominated Adrienne Matson to serve as chairperson. Ben Mudd seconded, and the motion passed unanimously.

**Discussion** Adrienne Matson provided an explanation of continuous professional development. She advised that ACPE is looking as implementing CPD and has requested a representative appear before the committee. There is currently no national clearinghouse for CPD. Katie Busroe advised that other states have implemented this and found it to be cumbersome. Three other states found no interest in pharmacists using CPD. They continue to use continuing education.
